

## **Promotion Terms and Conditions – “Bundle Discount”**

### **§ 1 GENERAL PROVISIONS**

**The promotion will be conducted under the name “Bundle Discount” (hereinafter: the “Promotion”). The conditions for participation in the Promotion are defined exclusively in these terms and conditions (hereinafter: the “Terms”).**

1. The organizer of the Promotion is Entire M sp. z o.o. based in Wrocław, al. Architektów 7, 54-115 Wrocław, entered into the register of entrepreneurs kept by the District Court for Wrocław Fabryczna in Wrocław, VI Commercial Department of the National Court Register under KRS number 0000410970, NIP: 8943037908, REGON: 021820847, share capital 100,000.00, fully paid up (hereinafter referred to as the “Organizer”).
2. The Promotion will be carried out in the HELIKON-TEX online store, available at [www.helikontex.com](http://www.helikontex.com) (hereinafter also referred to as the “Point of Sale”).
3. In parallel with these Promotion Terms, the HELIKON-TEX store Terms and Conditions, available at [www.helikon-tex.com](http://www.helikon-tex.com), shall also apply.

### **§ 2**

#### **PROMOTION RULES**

1. The Promotion will be conducted from November 4 , 2025 at 10:00 am until November 14, 2025 at 08:00 Polish time (UTC +01:00) (hereinafter: the “Promotion Period”). The Promotion Period may be shortened if the promotional product stocks described in paragraph 3 below are exhausted.
2. Any person who, during the Promotion Period, makes a purchase in the HELIKON-TEX store (hereinafter: the “Participant”) of a bag or backpack will receive the opportunity to make a promotional purchase.
3. The promotion consists of reducing the prices of products in the "evacuation products available at <https://helikon-tex.com/en/listings/evacuation-equipment.html>" category according to the following rules:
  - 1–2 evacuation products in the cart – 10% discount
  - 2–5 evacuation products in the cart – 15% discount
  - 6 or more evacuation products in the cart – 20% discount
4. The discount will be applied automatically in the cart after adding the products referred to in section 3, once the Participant meets the Promotion requirements.
5. The Promotion is open to any natural person with full legal capacity (18 years of age or older and not partially or completely incapacitated within the meaning of the Civil Code) making retail purchases for private purposes. Persons without full legal capacity may participate in the Promotion only with the participation of their statutory representative/legal guardian, who has read these Terms and accepted its provisions.

6. Participation in the Promotion is entirely voluntary.
7. The Promotion does not apply to wholesale purchases. Wholesale purchase means a purchase during the Promotion Period with the intention of reselling the ordered products.
8. The Promotion cannot be combined with any other price promotion or other discount codes.
9. If the cart contains products other than those included in the promotion, the discount will not be applied.

### **§ 3**

#### **WITHDRAWAL, RETURNS AND EXCHANGES**

1. A Participant who is a consumer may withdraw from a distance contract without giving any reason within 14 days from the date of purchase.
2. In the event of partial withdrawal from the contract (for one or several products) in such a way that the Participant no longer meets the condition for participation in the Promotion specified in § 2 section 2 or where the number of products does not entitle them to the discount level specified in § 2 section 3, the Participant is obliged to also return the product purchased under the Promotion.
3. Failure to return the promotional product in the case described above will result in the automatic restoration of the original (base) price of that product and the Organizer's right to demand payment from the Participant. In such a situation, the Participant agrees that the Organizer may deduct the original price of that product from the funds refunded to the Participant due to partial withdrawal from the contract.
4. In all other respects, returns and exchanges of products are carried out in accordance with the general rules available at: <https://helikon-tex.com/en/returns-and-complaints>.

### **§ 4**

#### **COMPLAINTS**

1. Complaints are handled by the Organizer. Complaints should be submitted in writing (by registered letter) to the Organizer's address with the note "Bundle Discount" on the envelope. A written complaint should include at least: the Participant's first and last name, exact address, description and reasons for the complaint.
2. Complaints will be processed within 14 days. After exhausting the complaint procedure, the Participant has the right to pursue claims before the competent common court.

### **§ 5**

## **PERSONAL DATA PROTECTION**

1. By participating in the Promotion, the Participant agrees to the processing of their personal data by the Organizer as the data controller.
2. Providing personal data by the Participant is voluntary but necessary to participate in the Promotion, and such data will be processed in accordance with applicable personal data protection regulations, in particular with Regulation (EU) 2016/679 of the European Parliament and of the Council of April 27, 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation) (OJ EU L 119, p. 1) for purposes related to the organization and conduct of the Promotion, in particular for financial and accounting purposes related to the issuance and settlement of goods issued under the Promotion.
3. The personal data of Participants will be processed for the period necessary to carry out the Promotion and fulfill orders, and for the period necessary to pursue and defend potential claims – until the statute of limitations for such claims expires.
4. The Promotion Participant has the right to request access to their data, its rectification, deletion (unless it prevents the fulfillment of the administrator's legal obligations), restriction of processing, the right to transfer their personal data, and the right to object. The Participant also has the right to lodge a complaint with the data protection supervisory authority – the President of the Personal Data Protection Office.

6. The Organizer does not intend to transfer the data of Promotion Participants to a third country or an international organization.

### **FINAL PROVISIONS**

1. The rights and obligations of the Organizer and Participants are defined exclusively in these Terms.
2. All data contained in advertising materials available at the Point of Sale are for information purposes only.
3. These Promotion Terms will be available online at the Point of Sale and at the Organizer's registered office.
4. Participation in the Promotion constitutes acceptance of its rules contained in these Terms.

5. The Organizer reserves the right to amend the Terms during the Promotion Period, provided that such changes do not infringe rights already acquired by Participants.
