#### Terms & Conditions of the "WINTER SALE"

## § 1 GENERAL PROVISIONS

- 1. The promotion will be called "WINTER SALE" (hereinafter referred to as the "Promotion"). The conditions of participation in the Promotion are set out solely in these terms & conditions (hereinafter referred to as the "Terms & Conditions").
- The Organizer of the Promotion is Helikon-Tex Sp. z o. o. with its registered office in Wrocław at ul. Radomska 34, NIP: 8943037908, REGON 021820847, entered into the Register of Entrepreneurs of the National Court Register by the District Court for Wrocław - Fabryczna, VI Commercial Division of the National Court Register under number 0000410970, with a share capital of PLN 100,000.00, fully paid up (hereinafter referred to as the "Organizer").
- 3. The Promotion will be conducted in the HELIKON-TEX online store, available at <u>www.helikon-tex.com</u>, hereinafter referred to as the "Point of Sale", where the Promotional Products will be available.
- 4. Parallel to the Terms & Conditions of the Promotion, the Terms & Conditions of the HELIKON-TEX store, available at <u>www.helikon-tex.com</u>, also apply.

#### § 2 PROMOTION RULES

- 1. The promotion will be conducted from January 2, 2023, from 08:00 until February 1, 2023, until 7:00 Polish time (UTC +01:00), hereinafter referred to as the "Promotion Period".
- 2. The promotion consists of the possibility of purchasing specially marked goods (see "Promotional Products"), available in the HELIKON-TEX online store, at a discounted price.
- 3. Promotional Products these are products available in the HELIKON-TEX online store under the "Promotions" tab and are marked with " WINTER SALE" labels.
- 4. A natural person with full legal capacity (18 years of age and not partially or fully incapacitated within the meaning of the Civil Code) who purchases goods in retail quantities for private purposes may participate in the Promotion. Persons who do not have full legal capacity may participate in the promotion only with the participation of their statutory representative/legal guardian who has read the content of these Terms & Conditions and accepted its provisions.
- 5. Participation in the Promotion is entirely voluntary.
- 6. Each Promotion Participant may participate in the Promotion multiple times, each time meeting the conditions set out in the Terms & Conditions.
- 7. The promotion does not apply to wholesale purchases. A wholesale purchase is understood as a purchase during the Promotion period with the intention of further resale of the ordered products.
- 8. The number of Promotional Products is limited.
- 9. The Organizer of the Promotion reserves the possibility of shortages of the promotional assortment in the online store helikon-tex.com.
- 10. The promotion does not add up with any other price promotion or discount codes.
- 11. The Organizer of the Promotion reserves the right to extend the delivery time of orders placed during the Promotion.
- 12. The Organizer of the Promotion reserves the right to end the Promotion before the time indicated in § 2 point 1.

# § 3 RETURNS AND EXCHANGES

- Product returns are made in accordance with the general rules available at: <u>https://www.helikon-tex.com/en\_pln/exchange-returns</u>. After returning the goods, the customer is not able to take advantage of the Promotion again after the end of the Promotion, nor are they entitled to other benefits of the Promotion.
- 2. In the case of returns of goods purchased under the Promotion, as part of the exchange of the product for the same product of a different size or color, the Organizer undertakes to grant the customer the benefits of the Promotion, even when the product is replaced after the end of the Promotion, provided that the exchange falls within the time limits specified in the general rules for returns and exchanges: <a href="https://www.helikon-tex.com/en\_pln/exchange-returns">https://www.helikon-tex.com/en\_pln/exchange-returns</a>.
- 3. In the case of returns and exchanges of products resulting from the Organizer's mistake (e.g. sending the size, color of the product or product model inconsistent with the customer's order), the Organizer undertakes to grant the customer the benefits of participating in the Promotion, even when the exchange of products takes place after the end of the Promotion, provided that the exchange falls within the time limits set out in the general rules for returns and exchanges: <a href="https://www.helikon-tex.com/en\_pln/exchange-returns">https://www.helikon-tex.com/en\_pln/exchange-returns</a>.

## § 4 COMPLAINTS

- Complaints are considered by the Organizer. Complaints should be submitted in writing (registered letter) to the Organizer's address with a note on the envelope: "Summer Sales - Select Items up to 30% off!". A written complaint should contain at least: name, surname, exact address of the Participant, description and indication of the reasons for the complaint.
- 2. Consideration of the complaint lasts 14 working days. After the complaint procedure has been exhausted, the Participant has the right to pursue claims before the competent common court.

# § 5 PERSONAL DATA PROTECTION

- 1. By joining the Promotion, the Participant consents to the processing of his personal data by the Organizer as the administrator.
- 2. Providing personal data by the Participant is voluntary, but necessary to participate in the Promotion, and this data will be processed in accordance with the relevant provisions on the protection of personal data, in particular with the provisions of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27.04. 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation) (OJ L 119, p. 1) for the purposes of related to the organization and conduct of the Promotion, in particular for financial and accounting purposes related to the release and settlement of goods issued in the Promotion.
- 3. Participants' personal data will be processed for the period necessary to carry out the Promotion and fulfill orders, and to the extent necessary to pursue and defend potential claims for the period until these claims expire.
- 4. The Participant of the Promotion has the right to request access to their data, rectification, deletion (unless it prevents the fulfillment of the administrator's obligations under the law), processing restrictions, the right to transfer their personal data and the right to raise objections. The competition participant also has the right to lodge a complaint with the Supervisory Authority in the field of personal data which is the President of the Office for Personal Data Protection.

- 6. The Organizer does not intend to transfer the data of the Promotion Participants to a third country or an international organization.

## § 6 FINAL PROVISIONS

- 1. The rights and obligations of the Organizer and Participants of the promotion are specified only in these Terms & Conditions. All information available in the advertising materials available at the point of sale is informative.
- 2. These Promotion Terms & Conditions will be available at the Point of Sale and at the Organizer's office.
- 3. The Customer's participation in the Promotion means acceptance of its rules contained in these terms & conditions.
- 4. The Organizer reserves the right to change the terms & conditions during the Promotion, provided that these changes cannot violate the rights already acquired by the participants.
