

Promotion Terms and Conditions “Buy UTP Pants and Get a Belt for 1 PLN

§ 1

GENERAL PROVISIONS

The promotion will be conducted under the name “Buy UTP Pants and Get a Belt for 1 PLN” (hereinafter referred to as the “Promotion”). The conditions for participation in the Promotion are set out exclusively in these Terms and Conditions (hereinafter the “Terms”).

The organizer of the Promotion is Entire M Sp. z o.o., with its registered office in Wrocław at Al. Architektów 7, NIP: 8943037908, REGON: 021820847, entered into the Register of Entrepreneurs of the National Court Register by the District Court for Wrocław-Fabryczna, 6th Commercial Division of the National Court Register, under number 0000410970, with a share capital of PLN 100,000.00, fully paid up (hereinafter referred to as the “Organizer”).

The Promotion will be conducted in the HELIKON-TEX online store, available at www.helikon-tex.com, hereinafter also referred to as the “Point of Sale”.

In addition to these Promotion Terms, the HELIKON-TEX Store Terms and Conditions available at www.helikon-tex.com shall also apply.

§ 2

PROMOTION RULES

The Promotion will run from February 23, 2026, from 00:00 until March 31, 2026, until 23:59 Polish time (UTC +01:00) (hereinafter the “Promotion Period”). The Promotion Period may be shortened if the stock of Promotional Products described in section 3 below is exhausted.

Any person who, during the Promotion Period, makes a purchase in the HELIKON-TEX store (hereinafter: the “Participant”) and purchases UTP Pants – PolyCotton Stretch Ripstop (SP-UTL-SP) will be entitled to purchase the Promotional Product – EDC Magnetic Belt (PS-EDM-NL-01) at the Promotional Price of PLN 1.00 / EUR 1 / USD 1.

The Promotional Price will be automatically applied in the shopping cart upon adding both products listed in section 2 above, and applies exclusively to one belt, regardless of the number of pants purchased in a single order.

The Promotion is open to natural persons with full legal capacity (at least 18 years of age and not partially or fully legally incapacitated within the meaning of the Civil Code) making retail purchases for private use. Persons without full legal capacity may participate in the Promotion only with the involvement of their statutory representative/legal guardian, who has read and accepted these Terms.

Participation in the Promotion is entirely voluntary.

The Promotion does not apply to wholesale purchases. A wholesale purchase shall mean a purchase made during the Promotion Period with the intent to resell the ordered products.

The Promotion cannot be combined with any other price promotion or discount codes.

§ 3

WITHDRAWAL FROM THE CONTRACT, RETURNS AND EXCHANGES

A Participant who is a consumer may withdraw from a distance contract without giving any reason within 14 days from the date of sale.

In the event of withdrawal from the contract in full, the Participant is also obliged to return the Promotional Product.

In the event of partial withdrawal from the contract (with respect to one or more products), in such a way that the Participant no longer meets the condition specified in § 2 section 2 (at least one pair of the above-mentioned UTP pants in the cart) entitling them to purchase the Promotional Product at the Promotional Price, the Participant is also obliged to return the Promotional Product.

Failure to return the Promotional Product in the cases described in sections 2 and 3 above will result in the automatic reinstatement of the original (base) price of the Promotional Product and entitle the Organizer to claim payment of that price from the Participant. In such case, the Participant agrees that the Organizer may deduct the original price of the Promotional Product from the amounts refunded to the Participant due to full or partial withdrawal from the contract.

§ 4

COMPLAINTS

Complaints shall be considered by the Organizer. Complaints should be submitted in writing (by registered mail) to the Organizer's address with the note on the envelope: "Buy UTP Pants and Get a Belt for 1 PLN". A written complaint should include at least: the Participant's first and last name, exact address, a description and indication of the reasons for the complaint.

Complaints will be processed within 14 business days. After the complaint procedure has been exhausted, the Participant has the right to pursue claims before the competent common court.

PERSONAL DATA PROTECTION

By participating in the Promotion, the Participant consents to the processing of their personal data by the Organizer as the data controller.

Providing personal data by the Participant is voluntary but necessary to participate in the Promotion. The data will be processed in accordance with applicable data protection laws, in particular Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 (General Data Protection Regulation – GDPR), for purposes related to the organization and conduct of the Promotion, in particular for financial and accounting purposes related to the issuance and settlement of goods provided under the Promotion.

Participants' personal data will be processed for the period necessary to conduct the Promotion and fulfill orders, and to the extent necessary for pursuing or defending potential claims – until the expiration of the applicable limitation period.

The Participant has the right to request access to their data, rectification, erasure (provided this does not prevent the controller from fulfilling legal obligations), restriction of processing, the right to data portability, and the right to object. The Participant also has the right to lodge a complaint with the supervisory authority for personal data protection, i.e. the President of the Personal Data Protection Office.

The Organizer does not intend to transfer the personal data of Promotion Participants to a third country or international organization.

FINAL PROVISIONS

The rights and obligations of the Organizer and Participants are set out exclusively in these Terms. Any information contained in advertising materials available at the Point of Sale is for informational purposes only.

These Promotion Terms and Conditions will be available online at the Point of Sale and at the Organizer's registered office.

Participation in the Promotion constitutes acceptance of the rules set out in these Terms.

The Organizer reserves the right to amend these Terms during the Promotion Period, provided that such amendments do not infringe upon rights already acquired by Participants.
